1. The City Council of Dodoma has set aside funds for the operation of the City Council of Dodoma during the financial year 2018/2019. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the Provision of town planning, and cadastral survey services of 82,518 Plots at Ntyuka, Mkonze, Mbabala, Ng'ong'ona, Zuzu, Hombolo, Makutupola, Kilimani, nad Kizota Mtumba, the City Council of Dodoma.
2. The City Council of Dodoma now invites sealed Tenders from eligible registered surveyors by National Council of Professional Surveyors (NCPS) and Town Planning Registration Board (TPRB) under Ministry of Land for Provision of town planning, and cadastral survey services of 82,518 Plots at Ntyuka, Mkonze, Mbabala, Ng'ong'ona, Zuzu, Hombolo, Makutupola, Kilimani, nad Kizota Mtumba, the City Council of Dodoma. 

Interested eligible Tenderers may obtain further information from and inspect the Tendering Documents at the office of the **Secretary of Council Tender Board, the City Council of Dodoma – HQ, Former CDA Building, P. O. Box 1249, Dodoma** from **07.30 to 15.00 Hours** on Mondays to Fridays inclusive except on public holidays.
5. A complete set of Tendering Documents in **English** and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 5 above and upon payment of a non-refundable fee of fifty thousand

shillings only. Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to **City Director - The City Council of Dodoma**.

6. All Tenders must be accompanied by a Tender Securing Declaration in the format provided in the Tendering Documents.
7. All Tenders in one original plus **two copies**, properly filled in, and enclosed in plain envelopes must be delivered to the address the **City Council of Dodoma - HQ, Former CDA Building, P. O. Box 1249, DODOMA** at or **before 21st March, 2019 at 10.00 Hours**. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at the **Board Room- 2nd Floor, the City Council of Dodoma - HQ, Former CDA Building, DODOMA**.
8. Late Tenders, portion of Tenders, electronic Tenders, Tenders not received, and not opened and not read out in public at the Tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
